News:

"We are ready for the challenge of participation for the poorest people in Europe"

At the European Fourth World Popular University, "Constructing a Europe without poverty or exclusion with young people", which was held on November 8 2010 at the EESC (European Economic and Social Committee) in Brussels, Isabelle Perrin, deputy director general of ATD Fourth World stated:

"Today we have shown that people with experience of poverty have ideas and, when they can share and combine them with those of others, new thought is created. These ideas are forged in the context of struggle, with the pride of continuing the fight against injustice at a time when it would be easy to give up because of how hard life is."

"You have spoken of your hope of finding partners in local neighbourhoods, at school, at work, in town halls and in political circles, of creating this school where knowledge is no longer a source of competition, but is shared between everyone, of policies for employment and training that are effective and free from discrimination or labelling, of supporting your families who are your first source of support for your projects at all levels, including your determination to create solidarity in your neighbourhoods."

"We also have ideas for Europe. We want a Europe of human rights and not a Europe of handouts. We want a Europe which refuses to give up, which is why we are so concerned to hear that the number of poor people is supposed to be reduced by 25%, and the number of children disconnected from education from 15 to 10%. What about the rest?"

"Participation is an important topic in today's Europe. It still poses a challenge to us, to Europe and the world. The challenge is to create the conditions for people who would normally never meet to speak to one another without fear or ulterior motives and to reflect together. We are ready and willing to meet this challenge, together with Europe."

The European platform against poverty and social exclusion

This platform is one of the 7 "flagship initiatives of the 2020 strategy. It aims to foster the joint engagement of Member States, European institutions and major interested parties in the fight against poverty and social exclusion." Since its adoption, ATD Fourth World has been calling for concrete policies to be applied in line with the following principles:

- •To ensure that the policies are effective for the poorest people
- •To develop tools to tackle extreme poverty in order to respect Human rights
- •To end intergenerational poverty
- •The think and act in partnership with the poorest people
- •To implement the horizontal social clause
- •To draw on social innovations and pilot projects Find out more...

- "To create policies which take the poorest people into account; to create a "reporting schedule" with concrete objectives and diversified indicators for the fight against poverty, and to ensure an annual evaluation
- •To guarantee real dialogue with the poorest people by involving all parties concerned, particularly social partners and civil society actors
- •To recognise the link between poverty and Human rights and to guarantee access to and the effectiveness of these rights (through applying the study of the Fundamental Rights Agency: Extreme Poverty and Human Rights)
- •Deputies and officials of the European institutions must participate in training on poverty and social exclusion, with people who have experienced poverty as trainers".

2010 Innovations Brussels: February 13 - 17

Belgium recently hosted the fourth and final meeting of "2010 Innovations" which was launched in Belgium by Globul'in, Haus Neudorf in Germany, Eurocef¹ in France and ATD Fourth World in Poland.

This programme of exchanges aimed to facilitate a Europewide meeting of social workers, educators, students in these fields and the beneficiaries of social aid. Participants (50 to 100 people) met in 4 countries and then set out to look for innovatory projects for delivering family support and accompaniment.

The website www.innov2010.eu features a number of working papers that were created as part of the project.

Participants are now preparing a document to report on their findings. They are committed to innovation in their workplaces and within this fruitful new partnership between aid services and beneficiaries.

In 2012, members will meet to share their experiences and new practices.
